148/23 Minutes: to approve or amend the minutes of the meeting held on the 11th September 2023. Proposed and seconded to approve and signed by the Chair.

151//23 Report by East Devon District Councillor J Kemp: it was agreed that the Clerk contact EDDC again.

#### 152/23 Devon County Councillor S Randall-Johnson:

The Clerk has circulated Cllr Randall-Johnson's report to all Councillors for October. It was stated that there was nothing relevant to the Parish Council in her report.

153/23 Updates on Councillors' Responsibilities.

Footpath: the proposed diversion of paths 7 and 5: Cllr Drake replied to Richard Spurway to inform him that following discussion between the landowner and Highways. the Parish Council saw no reason for him not to go ahead with posting the notice requesting a change of routes to paths 4 and 7 in Upton Pyne. We have advised Parishioners that there will be a notice put up. It is then up to Highways to consider any objections or letters of support before making their decision to notify Richard Spurway. Individual Parishioners are invited to comment on the proposals. A new kissing gate has been supplied by Highways for the landowner to keep walkers away from the turkeys, and a bridge has been repaired on the path from Robins Cottage to Brampford Speke. Cllr Drake to reply to Richard Spurway about grading the undercut path at Glebelands/Bidwell.

#### **154/23 Finance:**

### To sanction payment of accounts:

- a. Clerk's wages: for October 2023: £385.92 plus Home Allowance of £40=£425.92. Extra Hours: UPPC meeting: 2.5 hours and 1 hour for travel to notice boards = 3.5 hours add 1.45 hours site meeting held on  $6^{th}$  October 2023 = 5.15 = £62.11. Total = £488.03. Proposed and seconded to approve.
